GROVES ECONOMIC DEVELOPMENT CORPORATION BUSINESS GRANT PROGRAM FISCAL YEAR 2023 – 2024

PROGRAM OVERVIEW:

This program will provide reimbursement grants at 40% and 100% for eligible projects that are designed for improvement of business locations to enhance the atmosphere of the GROVES business community. This grant program will encourage growth and promote economic vitality within the City of GROVES. Eligible businesses may apply for up to \$15,000 through this matching grant program.

GOALS OF THE GRANT PROGRAM:

- 1. To encourage growth and promote economic vitality within the City of GROVES.
- 2. To support the GROVES business community in efforts for expansion, development and positive impact.
- 3. To encourage revitalization, renovation and development that enhances the atmosphere of the GROVES business community.

GRANT PROGRAM CRITERIA:

Businesses located in "commercially zoned" areas within the City of GROVES are eligible to apply. Business must occupy the building or location submitted for consideration in the grant application. Grant funds shall only be used for exterior elements of the business location visible to the general public and positive impact for the GROVES business community. Projects must be permanent, not seasonal or temporary, to be eligible for grant consideration. Grant awards will be paid upon completion of project and according to paid

receipts for project, from contractors, suppliers, etc., other than grant business or property owner. Grants are limited to one per business in each category in a fiscal year.

Sales Tax on an invoice will not be included in the GEDC Grant reimbursement.

Permit Application Fees will not be included in the GEDC Grant reimbursement.

- 2. Maximum award for all four (4) categories is \$15,0 00.
