ON FRIDAY, APRIL 21, 2023 FOR A COMMUNITY EVENT AND ALSO CONSIDER REQUEST FOR APPROVAL TO HAVE FOOD TRUCKS PRESENT: Councilmember Vensel made a motion to consider approval of a request to close Lincoln Avenue from Capitol to Jefferson from 3:00 p.m. to 8:00 p.m. on Friday, April 21, 2023 for a Community Event and also consider request for approval to have food trucks present and Mayor Pro Tem McAdams seconded. Juanita Dixon from Little Mommy's Boutique on Lincoln Avenue then introduced herself to Council and also introduced Yolani Illa who is their event coordinator. Mrs. Dixon stated that they looked over the application from Council for the road closure and they were able to get bids for Port a Potties and Event Insurance for that day.
