Commissioner Crain made a motion to deliberate and act to approve the Planning & Zoning Commission minutes of November 17, 2025, as written Chairman Plokhooy Seconded. There were no questions and the motion passed unanimously.

Concerns were expressed that commercial traffic will use Leonard and Dunn Street to avoid the signal light on Hwy 366 @ 39th Street. Building official Mr. Pedraza asked if new underground tanks will be put in. MAGNA representative, Mr. Snider stated that all new tanks will be installed. Mr. Pedraza stated he was hoping the drainage district representative was here today. They are going to have to do something either above ground or below for storm water. Mr. Pedraza stated the easement was going to be abandoned. Commissioner Campise asked if the abandoned easement would become part of the MAGNA property. Mr. Pedraza stated the abandoned easement will be replated into the MAGNA property. Mr. Pedraza asked MAGA representative Mr. Snider if he had a time of how long it will take to complete the project. Mr. Snider stated about 7 to 8 months. P & Z commissioners discussed which driveways will be removed and where the new ones will be installed.
